Mrs. Ford was elected Vice-Chair. Mrs. Chudasama was elected secretary. Also in attendance were PTA executive officers, Mrs. Mary Warren, Patsi Montineri, Gladys Romero. By-laws were reviewed and accepted without change.

Anjie Bowers, Chesney's Parent Instructional Coordinator, shared information on the School-wide Title 1 guidelines.
